4. First-aid measures

5. Fire-fighting measures

Methods and materials for containment and cleaning up Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Environmental precautions Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Avoid discharge into drains, water courses or onto the ground.

7. Handling and storage

Precautions for safe handling Avoid breathing mist/vapors. Avoid contact with eyes, skin, and clothing. Persons susceptible to allergic reactions should not handle this product. Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
